QUALIFICATIONS FOR ENTRY

Open to all Retriever breeds, Irish Water Spaniels, Standard Poodle, American Water Spaniels, Boykin Spaniels German Shorthaired Pointer, German Wirehaired Pointer, Irish Water Spaniels Vizsla, Weimaraner, Wirehaired Pointing Griffon that between August 1, 2012 and July 31, 2013 accumulates a total of 6 qualifications from a MN member club(s). In addition, every dog running in the MN event must also have an MH title from the AKC. Dogs which qualified at the 2012 Master National Hunt shall be credited with two passes.

NOTE: Absolutely NO phone, fax, or e-mail entries will be accepted. FEDEX, UPS, Airborne, US Postal Service, or any other overnight express delivery service will only be accepted with the "Signature Waived". **ALSO NOTE:** If you want to be notified of your entry receipt, include a SAS postcard. SAS postcard is the **ONLY** method the Hunt Test Secretary will reply via.
