Open to all Retriever breeds, Irish Water Spaniels, Standard Poodle, American Water Spaniels, Boykin Spaniels German Shorthaired Pointer, German Wirehaired Pointer, Irish Water Spaniels, Vizsla, Weimaraner, Wirehaired Pointing Griffon that between August 1, 2013 and July 31, 2014 accumulates a total of 6 qualifications from a MN member club(s). In addition, every dog running in the MN event must also have an MH title from the AKC. Dogs which qualified at the 2013 Master National Hunt shall be credited with two passes.

NOTE: Absolutely NO phone, fax, or e-mail entries will be accepted. <u>FEDEX, UPS, Airborne, US Postal Service, or any other overnight express delivery service will only be accepted with the "Signature Waived"</u>.
