Luann who has been very understanding and supportive throughout all of those years. I have two great children Kevin (27) and Torri (25) and three wonderful Grandchildren Meyah (2), Makaela (2) and Noelle (1). My family has been very helpful in assisting with training and spent many hours helping at the retriever club's functions.

I currently serve as a full-time Fire Chief for a combination fire department where I have been a member for the past 30 years. The job responsibilities have taken much time away from training opportunities but I thoroughly enjoy helping and working with people in their time of need and ensuring the safety of our citizens.

I started judging in 2003. I enjoy watching the retrievers and handlers work and think more people should take the opportunity to judge. I think you learn to be a better handler by judging because you get to closely watch the trials and tribulations of other handlers and dogs. I like to set up hunt tests that are challenging but not tricky. I like to set up tests that resemble hunting conditions I may see while I am hunting. There needs to be clear distinction between areas of the falls so you can see if the dog can mark. The dog should not be allowed to eventually stumble onto the bird. That whistle does you no good stuffed in your pocket. The dog should come to the line under control and be responsive to the handler on blind retrieves and handles. While I don't expect dogs to line the blinds, the handler needs to challenge the blinds with the whistles and casts necessary for a reasonable line to the blind. I encourage handlers to take their time coming to the line, take a deep breath, try to relax and have fun. Remember hunt tests are a team sport, the dogs and handlers need to work together to be successful.

Congratulations to those of you that have qualified and I would like to wish all contestants good luck!

# **Coming Soon to A Pedigree Near You**

The Master National Retriever Club (MNRC) Board of Directors has approved a proposal from the AKC for a new title for our retrievers. The AKC Board of Directors is expected to approve it by the first of the year. The title consists of awarding a Master National Hunter— "MNH" suffix to dogs passing three or more Master National Events (the current MNRC Hall of Fame requirements). The title is retroactive so it will be awarded to all dogs currently meeting the criteria. MNRC President, Janet Peters commented that "This is a meaningful piece of the history in the retriever hunting test program and a wonderful benefit to the retriever sport! It also shows the commitment and partnership between the MNRC and the AKC". MNRC Vision/Strategic Planning Committee Chair, Bill Teague, commented "we are deeply grateful to the AKC leadership, especially Doug Ljungren and Jerry Mann, for their support and guidance."

This development is the culmination of the work and passion of numerous people at both the MNRC and AKC over many many years but here is the recent history and further details on the title. At the MNRC's winter Board meeting in 2009, the Board approved renewed efforts to work more closely with AKC and the first meeting of representatives from both organizations was held in St. Louis, MO May 19, 2009. Representing MNRC were Dave Kress (Chairman, Vision/



Strategic Planning Committee), Janet Peters (incoming MNRC President) and Bill Teague (current President). The idea was to have the top two MNRC officers and the Chairman of the Vision/Strategic Planning Committee) represent MNRC each year to provide continuity and institutional memory. They would work with the AKC on issues facing both organizations. Representing the AKC were Doug Ljungren (Assistant Vice President, Performance Events) & Jerry Mann (Field Director, Sporting Breeds). Multiple topics were discussed, including AKC operations (with emphasis on the retrieverhunting test and field trial programs), adding

flights to the MNRHT, possible new titles, quality of testing the dogs, consistency of judge's scoring of dogs' performance, etc. The importance of having a "Master National based" title to represent and reward the achievements of these fine dogs and their handlers was noted in this meeting as one of the top desires of the hunt test community. Both organizations were pleased with the results and committed to continuing discussions. Since the May 2009 meeting, the dialogue has continued and one of the most encouraging results being the work on and subsequent approval of the new MNH title.

The new title administration will be simple and effective. Each year, the MNRC will advise the AKC of dogs completing the requirements (passes three MNRHT's) and pay a \$20 fee. AKC will add the MNH suffix to the dog's name and the title will be added to the dog's record. To recognize the dogs already meeting these criteria (i.e., the MNRC Hall of Fame dogs – see insert), the MNRC will provide the AKC information on all these dogs (about 135 as of the 2009 event) and pay the processing fee.

As a dog continues to pass multiple MNRHT's, a new title reflecting the dog's achievement will be awarded. For example, a dog that passes four MNRHT's will earn "MNH4", which supersedes the MNH. A dog that passes a fifth event will be earn MNH5, and so on.



If the owner wishes to have a certificate reflecting the new title on the dog, they will simply complete a form provided by the AKC, and submit the completed form with a payment of \$30. The dog's record and pedigree will contain the title whether or not the owner requests a certificate. The current "club title" (MNH) given to a dog passing 2 MNHRTs is currently under review by the Board and you'll be advised of their decision in future publications.

## 2010 Event–Progress in California

Well the local crew (Jay Phelps, JP, Janet Wood, and Kevin Bunnell) has this event pretty well cued up and ready to hand over to the 2010 Chief Marshall John Blackbird. We inspected the grounds last weekend and the new pond is in and holds water but has been drained to allow for planting and managing the cover. They will fill her up right after the judges arrive. The other ponds will start receiving water in about 2 weeks. Check out the MNRC Blog on the website for photos of the grounds from last week.

By the way, did you all realize that this is the **20th Running** of the MNRHT! Pretty exciting and certainly marks a milestone of this event. And we are about ready—committee assignments have been made, new equipment has been ordered and premiums are out and entries coming in daily! The schedule was included in the premium and is on the website. Training grounds assignments will be made in the Ramada Inn lobby. And remember—special rates for RV spots are only available by pre-paying and additional hotel space is available at the Holiday Inn Express in Corning, which is not charging an extra fee for dogs. The Host Club, Lassen Retriever Club, will have the majority of their clothing for sale **ONLY** via the internet—see www.101010masternational.com. They will have T-shirts and hats for sale at the event.

A few rules that we thought important to get to you soon and often: Don't drive and use your cell phone in California! Follow Fish & Game Rules for pre-event training and shooting. If you are traveling with firearms and staying at the casino, DO NOT bring into the casino—use the hotel only entrances. Otherwise you will have a personal escort out of the building. On the test grounds, follow posted traffic and speed signs. Watch out for Evel Knievel speed bumps. Park in desigated areas only. Air your dogs in designated areas only. Do not drive your vehicle or ATV (if you are a worker) through or across any green planted strips of vegetation. Learn about Fox Tails and know what to do if your dog snorts one. NO SMOKING ON THE GROUNDS—smoking allowed only in vehicles and at the gravel Clubhouse parking lot. Remember this is dry season in California and we are prone to wildfires—don't throw cigarettes out of your car—be careful with BBQs or any other fuels source—as Smokey says—"only you can prevent forest (or grass) fires. Please do not have bitches in season on the test grounds. Do not put them in the trash dumpster at either the casino or the test



grounds. ■ Follow the rules. Remember, the continued use of grounds like Clear Creek Sports Club depends on you following the rules and treating the property and owner respectfully. The local clubs depend on these grounds to hold their weekend hunts test and are hopeful that you will treat them with the kindness and appreciation that they deserve.

And last but not least—Safety! This is the responsibility of each and everyone of you. If you see something dangerous, stop what is going on and help us make it safe. If you are volunteering, make sure you understand or are briefed by the committee chair on how to safely operate the equipment and wear appropriate safety gear (e.g., hearing and eye protection, gloves, suncreen, etc). Know Safety No Accidents!
