# **2011 Master National Judges**



#### Dr. James Wonnell: Region 1—Florida

I was born and raised on a farm in central Indiana. High school involved mostly basketball, shop, and hunting. I got my first single barrel 16 gauge shotgun at 12 years of age. The farm and surrounding countryside offered excellent duck, pheasant and rabbit hunting.

After high school graduation I enlisted in the U.S. Marine Corps and spent three years on active duty achieving the rank of E-4 Sargeant and three years inactive reserve duty. I feel this and the farm years layed the ground work for my future.

In 1961 I enrolled in Purdue University in West Lafayette, Indiana for my pre-veterinary school classes. In 1963 I was admitted to the school of veterinary medicine program. I graduated from Purdue in 1967 and moved to Stuart, Florida. I have lived here ever since, have my own Vet Hospital and am still in active practice.

I am married and have two sons, Michael 32 and Jeffrey who is 29. Jeffrey went with me to the Master National in 2009 in Texas. My wonderful wife, Sarah is owner of Remedy Labradors and also was on the slate from Region 1 to judge the Master National several years ago, but did not judge.

I have qualified dogs for several Master national events, entered and ran dogs in five tests, 1999 was the first. I qualified three of those tests, GA, TX and VA. I have run AKC hunt tests for about eighteen years and have judged many tests, mostly being at the Master level.

The Master program events are set up to test, in my opinion, the average Master level dog. Some are far better and some are far worse. I feel a weekend test should be set so fifty percent of the field of dogs should be able to pass with all things considered. The program is established to test the abilities of a retriever against an established set of standards without tricks, competition or political interference. I feel most tests demonstrate a retrievers suitability and ability as hunting companions.

The Master National event is the super bowl for retrievers. Everything a weekend test provides, such as good use of ground cover, terrain, obstacles, bird placement along with the use of numerous decoys and good time management, the Master National provides only, with a greater degree of difficulty than the weekend hunt test, here proven Master Hunters are being tested.

A judge should display a good knowledge of hunting, have compassion, patience, know the rulebook and have a good understanding of the dog and handler team.,

Thank you for electing me to judge the 20th anniversary of the Master National, 2011. Good luck to all of you and above all else, have fun.

I know we as judges are probably not going to be your best buddies, but we are all sincere and will do the best job we can.

### DuWayne S. Bickle, Region 2 — Wisconsin

I was born and raised in southern Wisconsin and have lived my entire life enjoying the changing seasons and the bountiful hunting. I became interested in the sport when I met and became friends with my eighth grade science teacher who was involved in training Labrador retrievers for hunt tests. The more we talked the more interested I became in the sport. I began my weekly training as a "Bird Boy." I guess you could say I've worked my way up from the bottom.

I became interested in judging because I felt a true feeling of dedication to the sport and I wanted to be able to offer something in return for the enjoyment I received. At the time it seemed there were too few judges to go around and it was obvious this was an area I could lend both support to the organization and a helping hand. I thoroughly enjoy watching the teamwork that is demonstrated between a handler and his/her dog. The loyalty, trust and dedication displayed are a constant reminder that they are truly "best friends."

My most memorable experience with the sport is of the beginning of a close relationship that began when I competed in my first Master National in Glasgow, Delaware. I qualified my first Master Hunter, Sunny a yellow lab, and was invited to do some "pre-national" training several weeks before the national would be held. Due to my inexperience and being green to the sport I had never heard of this or the "early training" that followed in Delaware. Fortunately I was offered help from a key individual that was well versed in the routine of the sport and with "Big Brother's" advice and a few key training tips the National went off without a hitch. Sunny worked her heart out picking up all the birds making it look easy like she'd done this a hundred times before. Feeling proud of what we had accomplished together I felt confident that we had finished well. To our disappointment we later learned that we were to be one of only two dogs that did not qualify in the final test.

I soon got over the disappointment of that day, as did Sunny. We may have lost out that day where the Master National is concerned, but the friendships that were created from that experience were never lost. Today I have two of the best hunting partners and friends you could ask for. Together we have logged a lot of miles, good times and memories.

My definition of an exceptional hunting dog is a dog that marks well and uses his/her head when faced with confusing or complicated situations. The dog should be controlled and handle crisply to blinds or missed marks.

Style is extremely important to me. I look for a dog that displays a high level of intensity in difficult situations. I try to set up tests that are easy to score. I place my "falls" wide enough to judge then apply my hunting experience (how the birds would get there in a real hunt), to increase the level of difficulty. I believe in the use of calls at all stations to make sure the dog sees the "mark." Blinds should be placed so the handler can see the dog all the way to the bird.

At the completion of the Master National, my objective is to leave the handlers and the dogs believing that their abilities were challenged fairly and with the feeling that it was truly a rewarding experience for both.



# Dorthy Ruehman: Region 3— Texas

Training retrievers began as a necessity some 20 years ago during the duck hunting season, when I grew tired of my husband Michael's chocolate Labrador "Otis" taking all of my birds to him. ## MNRC and AKC welcomes special needs handler at hunt tests

The **Master National Retriever Club** in cooperation with the **American Kennel Club** is pleased to announce that special accommodations have been made to allow a disabled handler to enter the Master National event.



The AKC Performance Events Department has recognized Tommy Landers' desire to qualify for and enter the Master National. "The AKC is aware of Tommy's situation and believes the AKC should provide all reasonable accommodations for individuals with disabilities to enjoy the sport as long as it does not change the fundamental nature of the event," stated Doug Ljungren, Vice President of Performance Events.

Tommy, a 30-year-old from Arkansas and has been handling dogs for about three years. Tommy has Down syndrome. He began dog training with Dale and Denise Johnson, who have helped Tommy become the confident and enthusiastic handler familiar to the HRC

tests in the Louisiana and Arkansas region.

"Tommy comes to the line with the assurance and strut of John Wayne," says Denise Johnson. For years Tommy would just sit in the truck at tests, but when given some camouflaged clothes, a lanyard and whistle and the opportunity to handle a dog—he just blossomed into a confident and brave young man.

"Handling a dog at a hunt test has meant everything to Tommy. It has allowed him to cope with the outside world. It's the greatest thing in the world," says Tommy's father Bennie Landers. It has just brought him out of an egg shell and now he is outgoing, smiles all the time and can't wait for his next test."

Tommy was almost non-communicative before this experience happened, and now he will go up to a judge, shake their hand, and even "kiss" the women judges! It's the best therapy in the world says his dad.

Tommy's parents, Ann and Bennie Landers, of Arkansas City said they are extremely grateful to the **Master National Retriever Club** and the **AKC** for making accommodations for Tommy.

He will need assistance at the line, and his eye sight is limited, but Tommy can call out the commands, blow the whistle and handle the dog with some coaching. "His coach is just an extension of Tommy," says Denise. We may provide help by tapping him on the shoulder, but Tommy gives the commands.

Tommy will most likely be coached at the Master National by either handler Allen Sandifer or handler Tommy Harp, both of whom have been coaching the young man. Tommy will run one of Sandifer's or Harp's dogs at the 2011 event.

The MNRC is excited about seeing Tommy in Maryland and hopes all handlers will welcome him into the group.

When you see the smile on his face, you are sure to understand the pleasure and excitement this young man has gained from this enriched therapy says his dad.

# **Dollars and Sense – A Look at the MNRC Finances**

We would like to thank all of you for your interest and inquires regarding the financial status of the MNRC. We welcome such correspondence with our member clubs and stress that we have always and will continue to operate in a spirit of openness and transparency. It is unfortunate that the financial results of the 2010 event have been discussed out of context of both the event and the way the MNRC yearly cash flow cycles work. With this article we hope to bring about a better understanding of both.

Let's start with some facts about the cash flow of the MNRC events as I think the big picture should help you put 2010 in perspective. The MNRC rarely makes a profit at the Region 4 event, and generally does not make a profit in Region 1. The costs to conduct the event on the two coasts are simply too high. The last time we held the event in Region 4 (2006), there was about a \$21,000 loss without the extra expenses of capitalizing the third flight (see below) and we even saw a loss (\$31K) at the 2001Region 3 event for a variety of reasons. In general, the profits are made in Regions 2 and 3 (Figure 1). Our long-term and yearly event financial plans take these profits and losses into account, with the Region 2 and 3 events used to capitalize and cash flow the events in Regions 1 and 4.

As for the 2010 event, it was never budgeted to generate a profit from the beginning, and several factors occurred after the construction of the original event budget or at the event that increased the 2010 event loss beyond the anticipated deficit. Also, let us be clear – by a loss we mean that the event did not bring in more money than it cost to put it on. We also have another category of profit and loss for the administrative side of our activities and you need to examine both statements to understand the true financial standing of the MNRC. All of our financials (the administrative and event profit and loss (P&L) and the overall financial balance sheet of the MNRC) are distributed at the Annual Meeting every year and discussed with the delegates of the member clubs every year.

The major factors impacting the 2010 event financials are discussed:

- There was not a financial planning template to use for a 3-flight event so a straight increase of \$15,000 was applied on top of the amount predicted by our 2-flight template to predict costs for the 2010 event. As we were in new territory, we simply made our best guess. Subsequently, this template has been revised based on the actual 2010 costs and will aid us in continuing to make good financial decisions.
- The draft 2010 budget was not available at the 2010 Winter Meeting due to a critical work commitment that prohibited Frank Barton, MNRC Treasurer, from attending that meeting. This resulted in the Board making financial decisions (see next bullet) without a complete financial picture and did not allow for the rigorous debate and final approval of the budget that usually happens. Had we done this, I think we could have put additional measures in place or made some different decisions to slightly lessen the anticipated financial loss. Regardless, there would still have been a loss at the 2010 event.
- The Board approved, for the second year in a row, a lowering of entry fees. In hindsight, this was not a good decision but I commend the Board for continuing to look for ways to make this event more accessible to the majority who qualify.
- The 2010 event capitalized the equipment and supplies needed for the third flight and this capitalization was not in the 2010 Budget. Future events will not have this one-time cost.
- During the 2010 equipment trailer inventory, many of the supplies were found to be old, expired, or unusable. An extensive list was compiled and some of the needed equipment was donated by individuals or our sponsors but most was replaced and the expenses were charged to the 2010 event budget. These new supplies and equipment will be used for subsequent events.
- Our equipment trailer needed significant repairs this year along with new tires (which blew out once on the drive from Texas to California and again on the drive from California to Kansas. Fortunately no one was hurt.) Unfortunately, the 2010 event bore the cost for all the trailer related expenses.
- Worker expenses are always high on the West Coast as we just simply do not get the local club member support that we do in Regions 1, 2 and 3. We started using paid workers on the second day of the 2010 event whereas at other events, the paid workers were not needed until sometimes as late as Friday or Saturday. In addition, and unknown at the time the 2010 event budget was developed, California law requires that anyone using paid labor must have an Injury Illness Prevention Plan and must train all workers on the contents of this plan. This resulted in additional (non-productive) hours that we had to pay our workers in order for them to attend this training.
- A significant portion of our normal income was redirected (via loss of merchandise sales and auction income) to the Chase Away Canine Cancer organization (foundation?). While the MNRC believes that this is a good and charitable cause, we are stopping such charitable ventures until the member clubs can weigh in on the decision whether to essentially donate a portion of our revenue.
- Costs have just simply gone up and again are exacerbated on the West Coast. Prices for fuel, lodging, meals and supplies are simply higher in today's world. We have updated our financial planning template to account for this inflation in cost.

I think these are the most pertinent budget issues related to the 2010 event. While I agree that many of these costs should have been spread out between several events or accounted for on the administrative side that is not the way it has been done in the past and we chose to continue with past practices to allow for year to year financial comparisons.

In regards to the questions regarding cost controls, the MNRC has excellent financial planning tools but again keep in mind the newness of the 3-flight event. The template used for the 3- flight event was gone over exhaustively at the 2011 Winter Meeting and the revised tool should allow us to better plan future events. In addition, the 2011 event draft budget was discussed and debated at length at this meeting in an effort to ensure the best financial decisions were made.

Another factor that affected the 2010 financial year is that this was the first year that our new committee costs were felt. In response to overwhelming input from you that we needed to upgrade our program especially in regards to communication and safety, we had additional costs related to these issues (e.g., status texting, new chair members, website overhaul, website updates during the event, etc). In addition, much time was spent in 2010 and prior years in working with the AKC on the MNH title. I think everyone agrees that the improvements in these areas were badly needed but these improvements do not come without some incremental cost.

The MNRC policy requires that our financials are audited yearly and this is religiously done. We also performed a long-term financial analysis in early 2011. The results have been incorporated into the 2011 event discussions and decision making process to determine exactly what our income streams needed to be and what costs/expenses were necessary and what we should cut.

In summary, the 2010 event was never expected to bring in more money than it cost to put on. There were some equipment and trailer related costs that were allocated against the 2010 event budget, as well as higher than anticipated labor costs. The additional flight ended up costing more than expected. When you combine these with a reduction in entry fees and the redirecting of a portion of our usual revenue to Chase Away Canine Cancer, the result is a net loss that exceeded that anticipated by the Board. In fact if we add up these unanticipated costs they account for the majority of the unplanned 2010 event deficit. As we do every year, the Board has used the lessons from 2010 in our planning for future events.

Again, I'd like to thank those of you who inquired about this matter for your interest in the MNRC financials. This Board remains committed to openness and transparency in our dealings with the member clubs, and we welcome the opportunity to share these details with you all.

As always the full MNRC financial report will be presented and discussed at the annual meeting. The financial performance of the MNRC is well documented and understood. This Board takes our fiduciary responsibilities very seriously and believes that we have been good stewards of the MNRC. What the 2010 event really shows is our continued growing pains – over the years we have grown this event from a single flight event to a 3 fight event. Along with that growth, we have been able to deliver many of the upgrades and desired improvements to the MNRC.
